

PWT instructions for orders delivered directly to INDIA

Size label

- Same as regular order

Price sticker

- Sticker should not have prices! Only style number, color, size, EAN number / barcode.
- MRP STICKER is needed. Sticker will be provided by ICONIC INDIA and sent to the suppliers.
- Please see last page regarding MRP sticker.

Packing:

- No hanging goods allowed.
- All goods should be packed in boxes

Carton/shippingmarks:

- Same layout as regular order

Shipment & Booking

- Forwarder = Goods should be handed over to AREMEX or MGX (they will inform you)
- When making the booking at the nominated forwarder the logistician **must** be in cc.

- FREIGHT CERTIFICATE (*from consignee on its letter head*)
- COST SHEET (*confidential information – as long as the final amount is correct, the other numbers may be fictive*)
- AZO test certificate (test will be paid by costumer)
- Sales Contract between PWT and Supplier with ICONIC FASHION mentioned as consignee (*this sales contract should only contains IN orders – and should only be mentioning ICONIC FASHION as consignee – no need to include all other orders*)

Please note that all above documents MUST be **signed** and **stamped**! Please be aware, that factory and supplier information must be 100% correct and the same in all documents.

AZO TEST NEEDED FOR ALL ORDERS FROM BANGLADESH:

Costumer needs AZO test for each style in each color.

Test will be arranged and paid by costumer.

You need to arrange sample and printed AZO test form to be handed over with the goods.

Test form will be provided by PWT. You only need to fill in your information.

When sample and test from is ready for pick up, please contact Yogesh Goswami (yogesh.goswami@iconicindia.com)

When the sample has passed the test, the costumer will pick up the goods for shipment.

MRP STICKERS NEEDED FOR ALL ORDERS

MRP stickers are needed for all orders shipped to India.

The stickers will be provided from our costumer ICONIC INDIA.
